


DSM-5 is the diagnostic classification system for psychiatrists and other mental health professionals that describes the essential features of the full range of mental disorders. Reliable diagnoses are essential for guiding treatment recommendations, identifying prevalence rates for mental health service planning, identifying patient groups for clinical and basic research, and documenting morbidity and mortality

rates. DSM-5 fills the need for a concise description of each mental disorder organized by explicit diagnostic criteria, along with a brief digest of information about the diagnosis, risk factors, associated features, research advances, and various expressions of the disorder.

The DSM-5 is an essential diagnostic tool for promoting effective mental health diagnosis, treatment, and quality of care.

- Assessments with online access
- Cross referenced to both ICD-9 and ICD-10
- New organizational structure that harmonizes with ICD

- New category for autism spectrum disorder






DSM-5 Guidebook will provide practicing clinicians a useful “owner’s manual” for implementing DSM-5 into their practice. Chap-


The *Study Guide to DSM-5* is an indispensable companion to DSM-5 designed to help students, residents, and clinicians understand the

DSM-5 Handbook of Differential Diagnosis is a succinct reference to help ensure that clinicians consider all of the important diagnoses


that need to be ruled out during a clinical evaluation. It is a great convenience for busy practitioners and a valuable overview for trainees.
